1.0 CALL TO ORDER, NOTICE OF MEETING AND PROOF OF MAILING

9.1 Report presented by Chair Resby Coutts (see addendum)

9.2 Announcement by Resby Coutts of Board Chair for 2018-2019 and Remarks Regarding Vice Chair's Position

I have reported with great pride on the accomplishments of the entire Curling Canada Team over the past year. Before we move ahead with the agenda, I want to speak about my immediate objective going forward. In an hour or so, I will assume the position of Past Chair on the 2018-19 Board of Governors. I want to move forward immediately on the most urgent item in regard to by-law amendments.

The Board Structure Task Group's discussions over the past year recommended removal of the position of the Vice Chair from the By-laws as a move toward current best practices. The Presidents endorsed that action on Wednesday, September 26 during the working lunch discussion on Board Structure. We are in the interesting position of being able to move forward immediately with that recommendation.

At the Board election held on Wednesday, September 26, the outgoing board members (as provided for in the current By-laws) elected Maureen Miller Chair of Curling Canada for 2018-2019. Congratulations, Maureen. Currently, the By-laws specifically state that the election of officers by the outgoing Board must take place before the Annual Meeting. Once we convened the Annual Meeting for the election yesterday – the responsibility for any next steps in regard to election of officers automatically fell to the incoming 2018-19 Board.

I must report the result of the election for Vice Chair was vacated by the result of the election of Governors held yesterday morning. Therefore, responsibility in regard to discussion of the Vice Chair position now falls to the Board meeting that will take place this afternoon.

As Past Chair, I will still be a sitting Governor. In consultation with legal counsel and Parliamentarian Adam Klevinas, I will be proposing a motion to expedite. My motion will be to call a Special Meeting of the Members to deal with a by-law amendment to remove the

position of Vice Chair from the By-laws. The other topics included in policy and By-law amendments discussions can be dealt with on the original timeline – aiming toward a December vote.

I believe we can move forward on the specific question of Vice Chair and I will ask the new Board to allow me to lead the drafting of a by-law amendment. The motion, however, will be a simple one that will read:

Be it resolved that the Board of Governors call a Special Meeting of the Member Associations within 21 days of today for the purpose of approving a by-law amendment to remove the position of Vice Chair from the Curling Canada By-laws.

It is an ambitious timeline but it can be done. By doing this, we put in place a best practice which was recommended by the Board Structure Task Group and endorsed by the MA Presidents in the Governance meeting held earlier this week. The continuing members of the Curling Canada Board have been made aware of this proposition and I will do my best to bring the newly-elected Governors up to speed as quickly as I can after we adjourn today.

- e) To be an active and positive influence in international curling through positive participation with the World Curling Federation and other National Curling Associations
- f) To respect and preserve the history and heritage of Canadian curling, and to recognize and honour the achievements of athletes and builders in the sport of curling.

Another first – all Season of Champions events showed a profit for the 2017-2018 fiscal. Curling Canada Directors Gord McNabb and Danny Lamoureux, along with Curling Canada's operations team, were recognized and thanked for their efforts with events management during this past season.

Bill Merklinger, Executive Director of Corporate Services, reported that, with the assistance of Collins Barrow, new procedures for crowd sweeps were developed allowing for a qualification which had been part of previous audits to be removed. Topics highlighted included the success of the Korean Olympics, the inclusion of a new discipline - Mixed Doubles, a new World Cup initiative, expansion of TV and streaming opportunities for the sport worldwide, etc.

Incoming Chair Maureen Miller thanked the Curling Canada Board of Governors for their show of confidence in electing her Chair for the 2018-2019 Season. She stated she plans to work together with the Curling Canada Board, staff and Member Associations to move our great sport of curling forward over the next year.

CURLING CANADA BOARD OF GOVERNORS CHAIR RESBY COUTTS 2017-2018 REPORT

It is a special opportunity, as Chair of Curling Canada's Board of Governors, to reflect on the successes of the past year. I do so with great pride in the accomplishments of Curling Canada as well as of our Member Associations over the past year.

The very positive financial report for the year is the result of the combined efforts of all – Board, staff, volunteers, athletes and thankfully fans who continue to rank our events as an entertainment priority. Also in the finances area – we are making a significant contribution to the reserve fund and, although not exclusively a financial item - we are refining our risk registry and implementing a more and more refined RFP – request for proposals – business approach. These are all great successes.

Curling Canada is viewed by many counterpart National Sport Organizations as a role model organization. The public perception of our organization is a very positive one based on observations of such things as very well organized, full-house national events and regular international podium appearances by our champions.

These are important components of our story. They are also important 'tools' in the Curling Canada toolbox – tools which provide the public exposure and the excitement we need to attract new people to our sport and to grow our sport.

On the international scene, there were an even dozen international medals available to our teams and those teams brought home a remarkable TEN medals. We are proud of the performances of all of our teams and we salute all of the players who wore the Maple Leaf whether for the first time or as another appearance in an already full and successful career. Equally, we salute the provincial champions and other qualifying teams who competed in our national events.

The fact that we are one of few (if any) national sport organization which can say our championships are true national championships with all provinces and territories involved is a point of pride for us and something which most others have long-since quit aspiring to. We must continue to protect that unique aspect of our efforts at the same time as we work to ensure our best teams have the opportunity to compete to represent us internationally.

On the national scene, there were outstanding performances by the volunteers in several new host communities. The season started with the Canadian Mixed in Swan River, a community which had never considered itself likely to host a national event. Portage la Prairie hosted the first ever Mixed Doubles Trials with great crowds who quickly understood the magic of this new discipline. Leduc hosted Curl-4-Canada, a first time format which brought together four of our championships at one time in one venue. And North Bay blew the doors off their arena with sell-out crowd after sell-out crowd. These stories do not diminish the successes in Penticton and Regina and our other host communities. However they are testimony to the success of the new event- bidding process which Curling Canada has implemented.

I am proud to report the Board of Governors has adopted a pioneering attitude – displaying willingness to evolve the Governance Model which has been in place for over a decade rather than falling back on the ageless "the way we always do it" as a basis of decisions. I am even prouder to recognize the dedicated and innovative service and leadership of our professional staff. It is obvious

every day that this is 'more than a job' for all of them.

As well, I want to recognize the Member Association Board members and staff members, both professional and volunteer. Together we have made progress but there is more to be done. I look forward to the continued progress we can make together in the year ahead.

And finally, as the year ends, I want to recognize the service of my nine colleagues on the Board of Governors but especially past-Chair Peter Inch, Lena West, Scott Comfort, and Catherine Hughes whose terms conclude. Their dedication to our sport has been an inspiration!
